



HOW TO ADD ADDITIONAL TICKETS/PASSES TO YOUR EXISTING REGISTRATION

(Note – you cannot add additional people to an existing registration, that must be done in a new booking through our registration portal)

There are two easy ways to add additional tickets (Sponsorship, Banquet, Wine Social etc) to your existing registration:

1. You can click the “If you need to modify your registration, follow this link” text located below your registration summary within the confirmation email you would have received:



When on the registration form, please select the bottom option “Pre-Registered Delegate – Registration Modification” to then see the optional items you can add to your registration populate below.

- You can go to our event registration portal anytime (reg.eventmobi.com/2026KEGConference) and click the small arrow on the right side of the “Register” button to select “Modify my registration”:



- Once you re-enter the portal, you will be able to see the items you have previously purchased (these will have a blue check mark inside a greyed-out box). You can then click upon any of the open opportunities or tickets you wish to add to your registration by selecting the bottom option “Pre-Registered Delegate – Registration Modification” :
- To proceed, click “Next” at the bottom of the screen.
- Ensure the contact details are still correct and then scroll to select “Next” to move to the Registration Summary Screen. Here it will note the items you have already paid for **AND** the new items. You will notice that the amount in the total will indicate the new amount owing.
